A guide to general dental practice (2006)

This paperback is a welcome addition to the general dental practitioner's (GDP) bookshelf, providing some valuable information for the graduate about to enter general practice. It has been produced by GDPs for GDPs, and is concise and clearly printed.

The book is divided into eight sections, and the final part gives useful lists of supply companies, dental organizations, and British Dental Association publications. The first section covers legal and ethical issues and explains the framework within which dentistry is practised in the United Kingdom. The following chapter covers clinical governance and its ever-increasing impact on present and future practice. There is a thorough and detailed section on medical history and its significance, and then a brief chapter on orthodontics, which reminds the general practitioner that, although most treatment is undertaken by specialists, it is the GDPs

responsibility to observe developing children's dentitions, and refer those in need at the appropriate time. This theme of referral is continued in the next chapter, which also deals with prescribing medication.

Section six deals comprehensively with dental and medical emergencies, a vital area of information.

A discussion of the importance of awareness of oral cancer completes the clinical portion of the book, and is followed by a discussion on the main management aspects of running a viable practice. This important section covers finance, surgery design, and setting up a practice.

This is a well-produced and handy little book, which at less than £20.00 is well worth a place in every practitioner's library.

Clinical success in surgical and orthodontic treatment of impacted teeth (2006)

This slim volume is concerned primarily with the management of ectopic maxillary canines and unerupted central incisors in relation to orthodontic appliance treatment. It is a well-laid out book, presenting the mechanisms of eruption and normal development of the dentition as a setting for the subsequent chapters on assessment, prevention, and surgical/orthodontic treatment of impacted teeth. Unfortunately, the attempt to attribute both genetic and environmental causes to the aetiology of ectopic canines leaves the reader more confused than convinced. However, the section on management of ectopic

canines, which occupies a major part of this textbook, is the main feature.

Mechanotherapy and both hard and soft tissue management are thoroughly discussed. The illustrations are profuse and of excellent quality, with computed tomographic scans and reconstructed three-dimensional images used to enhance clarity. The wide range of cases demonstrated is a reflection of the authors' experience in this field. This book would be recommended reading for postgraduates and clinicians alike.
