- C. Budget (Secretary-Treasurer P. Main)

A balanced budget was presented and approved unanimously. The budget was approved as circulated for 2000–2001. (P.Main/R. King)

There was discussion around the opportunities for promoting oral health in the current advantageous climate.

That the leadership of AAPHD develops and implements an action plan to improve the oral health of the public during this unique opportunity before and after the release of the Surgeon General's Report on Oral Health. The Executive Council is authorized to use such sums as are necessary from the association's reserve for the purpose, but that amounts in excess of 20 percent of the

- D. Education Committee (Dolan and Weyant)
 - DPH Resident Directors' Workshop
 The final report of Workshop 99 will be on the website. R. Weyant will chair the next workshop, which will include residents, as well. It will be held September 11–14, 2000.

- E. Awards and Nominations Committee (White)
 Call for nominations was announced.
- F. Science Committee (Atchison)
 The Science Committee reviewed abstracts for this meeting. A new call for abstracts for the 2001 meeting will be made early in the fall in Communiqué. Program evaluation will be added on the call for abstracts. All moderators and comoderators were thanked for their contributions to the meeting.

V. Executive Director

The executive director has had a busy six months since the 1999 meeting getting two meetings organized: the 2000 Oak Brook, Illinois, meeting and the 2001 Portland, Oregon, meeting. He will be catching up with the backlog once he returns home.

VI. Old business

A. Transition Meeting

This will be for a trial period of five years with a review undertaken after two to three years, so that a decision can be made for the final two years. The next meeting will be in Portland in 2001. Due to the merging of two separate two and a half-day conferences into three days, there has been some juggling of events. There will be an opportunity for feedback from the members through a survey in the next *Communiqué*.

B. Ethics Summit

This meeting identified issues that will be addressed at a future conference. D. Kleinman and R. Mecklenburg attended. The focus is on catching up and then there will be the need to identify elements to perpetuate. There is no desire to have a new organization, but rather to form a coalition with ACD as the directorate. AAPHD should have a representative at meetings from time to time.

C. Ethics Implementation Plan

A draft implementation plan dated April 2000 was presented. The issues around publication have been added to the plan presented in Hawaii. An appeals process has been added. There may need to be a timeline added. G. Rozier, A. Horowitz, and

K. Atchison will continue this work.

VII. New business

A. Consensus Statement on Dental Caries (A. Horowitz)

Horowitz addressed the planned consensus conference on dental caries to be held in March 26–28, 2001. ASTDD and AAPHD have been invited. Further information is available from her. The consensus conference is based on systematic evidence-based reviews, conducted partly through a contract with RTI through AHRQ and NIDCR. There was discussion about the Fluoride Report and ensuring that it too is evidence-based.

B. ADA Specialty Review

ADA is conducting a review of recognized specialties (nine in all). Data are required by August 1, 2000.

- C. Recruitment and retention of faculty (K. Atchison) K. Atchison is representing AAPHD on this task force, which is sharing issues such as recruitment.
- D. M. Cunningham has announced that she will step down as editor of the *Communiqué*, as of the next meeting.
